Shelton Memorial Park is a 501(c)(13) non-profit Private Cemetery governed by a Non-Paid volunteer Board of Directors and regulated by State of Washington Chapter 68.20 RCW.

Prices, Rules and Regulations adopted by the Board of Directors of the Shelton Cemetery Association are subject to change without notice. The rules shall govern the conduct of everyone who visits Shelton Memorial Park. Prices, Rules and Regulations shall accompany any and all interment/inurnment contracts. Copies are available upon request.

Shelton Memorial Park maintains an Endowment Care Fund. When a space is purchased, a portion of the purchased price is placed in an irreducible trust fund as outlined in Title 68 RCW. The principle of this fund must remain intact until the cemetery is full with no space available for interments or inurnments. The interest earned is used for the present and future maintenance of the Cemetery. The endowment care concept ensures the continuing maintenance of the cemetery long after those who provide the funds are gone.

The cemetery does not receive any funding from state or local taxes. The cemetery relies on items purchased at the cemetery, such as memorial markers, burial vaults, cremation niches, grave spaces and burials. You can help the cemetery by purchasing all your cemetery needs at our office. Stop by or call for an appointment.

#	Notes:
1	Each site purchase entitles the purchaser to one right of Interment/Inurnment, Memorial Privileges, and Endowed Care. A 15% Endowment Fee is included in the price for ongoing maintenance after the cemetery is full.
2	A Basic Full Burial Plot is generally considered to be four feet wide by eight feet long. This may vary in some cemetery sections. It's intended use is for one Interment or Inurnment. Extended Land Use allows up to three additional Inurnments on the Basic Plot.
3	Babyland Plots are about two feet by two feet. The intended use is for one Infant Interment or Inurnment.
4	A Basic Half Burial Plot applies to those of various smaller size that have been created over the years. Ongoing they will be utilized for Infant Internment or inurnment burials only.
5	Urn Garden Plots are about one and half feet square. The intended use is for one Buried Inurnment.
6	All Niche Walls are shown on list for complete reference. A price is only listed for those with available space.
7	Although not required by State of Washington Statutes, Shelton Memorial Park Cemetery does require an Outer Burial Container which helps to prevent ground collapse. Vaults are designed to reduce moisture intrusion. SMP makes no representation or warrants about the protective value other than those made by the manufacturer.
8	The General Interment/Inurnment fee includes Gravesite Opening and Closing, Administrative Service, A required inscribed marker and it's Installation, and Installation of the selected Burial Container, whether provided by Shelton Memorial Park Cemetery or Others.
9	Weekday Overtime Charges apply for Interment services scheduled after 2 PM, and for Inurnments after 3 PM. Saturday Charges apply with no Interment services scheduled after 2 PM, and no Inurnments after 3 PM.
10	Administrative Service includes, but is not limited to a share of insurance, business and state licenses, overhead to maintain office and shop facilities. It also includes filing and mailing burial/transit permits, maintaining records genealogical purposes indefinitely, and coordinating with funeral homes as required.
11	Survey, Inspection, and Supervision of installation for products not purchased at cemetery.
12	Added Labor of Grounds or Office Staff that is not included in standard offerings.
13	The price for SMP provided Markers includes installation as required. The listed fee is charged for installation of standard size Non-SMP Markers. Mega Marker installation quote available upon request.
